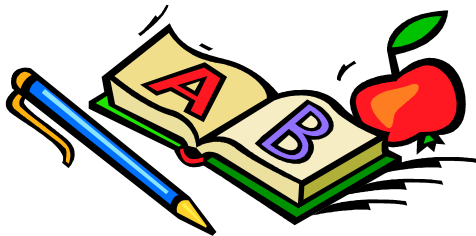


## Keep Your Tax Dollars in the Tucson Community

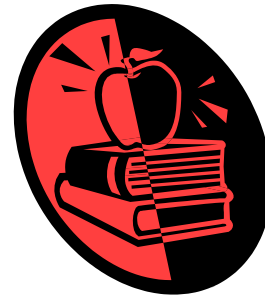

## How the Arizona Tax Credit Works

Contributions to Carden are always tax deductible. A Tax Credit allows you to subtract the amount of your contribution from the amount you owe to the State of Arizona on your income tax form— up to \$400 for a married couple & \$200 for a single person. A Tax Credit is a full refund of your money. Donations must be received at the school by April 1, 2019 to count for the 2018 tax year.

Tax credit funds provide the necessary money



for trips, as well as for the costs of special programs such

as the Annual Constitution Program, Dance Festival, Christmas Program and Washington D.C Trip.
